

## INSTRUCTIONAL MODEL: TRADITIONAL CLASSROOM LEARNING

#### **Return to the classroom**

Students and staff practice operational safety procedures to reduce the spread of COVID-19

#### Staffing

May be reassigned to support distancing and safety procedures, enabling students to return to the classroom

#### **Schedules**

Daily schedule has been modified (ex. lunch, recess) as necessary, with start and end of day bell times remaining the same

#### Grading

Traditional grading (Middle/High School: A-F, Winskill Elementary: Standards-based grading)

#### **Alternatives**

Students and families who are not comfortable will be provided an online/virtual option

#### Attendance

All students are required to attend their scheduled classes at the time they are offered. This includes all students, whether attending classes face-to-face or virtually

### **INSTRUCTIONAL MODEL: BLENDED LEARNING**

#### Grades 6-12

Will be used to reduce the number of students in larger secondary schools. Pre-kindergarten through fifth grade will continue traditional classroom learning

#### Schedule

Monday, Tuesday: Cohort A attends class; Virtual Learning for Cohort B Wednesday, Thursday: Cohort B attends class, Virtual Learning for Cohort A Fridays will be alternated

#### **Early Identification**

Teachers, schools and families will work together to quickly identify students struggling to engage

#### Grading

Traditional grading (Middle/High School: A-F, Winskill Elementary: Standards-based grading)

#### **Devices and Access**

Students will be provided a district device Families will need to have Internet access to accommodate virtual learning If Internet access is not available, families will need to notify the school district to collaborate on modifications

#### **Alternatives**

Students and families who are not comfortable with blended learning will be provided a virtual option five days per week

### **INSTRUCTIONAL MODEL:** VIRTUAL LEARNING

#### **Targeted or District-Wide**

May be used for short or long-term needs as determined Teachers, schools and families will work together to by positive COVID-19 cases

#### Schedule

School will be in session Monday - Friday Staff will be at school providing instruction Students will be at home

#### **Devices and Access**

Students will be provided a district device Families will need to have Internet access to accommodate virtual learning If Internet access is not available, families will need to notify the school district to collaborate on modifications

#### **Early Identification**

quickly identify students struggling to engage

#### Grading

Traditional grading (Middle/High School: A-F, Elementary: Standards-based grading)

#### **Attendance (progress monitoring)**

Classroom meetings and completion of assignments will be an indicator of involvement and attendance

### **OPERATIONS: DAY-TO-DAY**

#### Self health check

#### **Visitors**

No non-essential visitors and visits

#### **Cohorts**

Elementary classrooms will remain in static groups Limit interaction outside of classroom environment

#### **Entrances and Exits / Traffic flow**

All entrances will be locked Everyone within the building will follow the flow of traffic signs

If there is two-way traffic, all individuals are expected to walk single file and to their right side of the hallway

#### **Face Coverings**

All students and adults will be required to wear a face covering while in school district buildings

#### **Field Trips and Gatherings**

Limit and monitor conditions before final approval for trips and large school events

### **OPERATIONS: HEALTHY ENVIRONMENTS**

#### Ventilation

Increased filtration inspections will be scheduled All air filters have been replaced with higher density filtration material

#### **Cleaning and Disinfecting**

Middle/High School classrooms will be disinfected between classes

Winskill Elementary classrooms will be cleaned at the end of the day (students are in a cohort throughout the day)

All restrooms will be disinfected throughout the day every two hours throughout the school day

#### **Communal Spaces**

Middle/High School lunch rooms will be disinfected between uses

#### **Hand Hygiene**

Best practices will be taught and reinforced at all grade levels

### **OPERATIONS: PHYSICAL SPACES**

#### **Physical Barriers**

Barriers will be installed in office spaces, lunch rooms and classrooms Where social distancing is difficult

#### **Floor Adhesives**

Separation stickers (6') in high-traffic areas (ex: hallways, lunch line) Flow of traffic signs will be installed to indicate the direction of student/staff flow

#### Safety Signage

To promote safety, informational signage will be posted throughout school buildings:

- 1. Hand Hygiene
  - Social Distancing
     Face coverings
- 3. Symptoms

**Hand Sanitation Stations** 

Increased placement and encouraged usage Stations will be placed in each classroom, building entrances and exits, and lunch rooms

#### Locker Usage

Limited use Backpacks will be used during the day

#### **Isolation Room**

Isolation spaces are located in or near each school office

#### **Drinking Water**

Bottle filling only (students will be expected to bring their own water bottles for daily use) Drinking fountains will not be available

### **OPERATIONS: TRANSPORTATION**

#### **Student Capacity**

Efforts will be made to limit one student per seat on the bus (students from the same household may sit together) Students will be asked to sit at a window seat to

maximize social distancing

#### **Face Coverings**

Students will be required to wear face coverings to enter, exit and while riding the bus Drivers will be required to wear face coverings

#### **Health and Safety**

Buses will be disinfected following each route with special attention given to high-touch areas

#### **Self-Transport**

Parents and/or students planning to self-transport are encouraged to contact their school's office to increase accuracy of routes and staffing requirements With the help of our families who are able to transport their students, we can reduce our bus riders to enhance social distancing

### **EXTRACURRICULAR ACTIVITIES**

#### **WIAA Guidance**

Rely on and implement guidance from WIAA to safely hold athletic practices, competitions and events

#### **Moving Between Models**

Activities and events may be postponed or adjusted to reflect current conditions in schools or the community

#### **Clubs and Activities**

Clubs and activities will take place with social distancing and safety measures

### **DAILY SELF-CHECK FOR FAMILIES**

Symptoms may appear 2 to 14 days after exposure to the virus. If your child has any of the following symptoms, please keep them home until symptoms are resolved:

- Fever (Temperature of 100.4 or greater) or chills
- New loss of taste or smell

- Cough
- Shortness of breath or difficulty breathing
- Fatigue
- Muscle or body aches
- Headache

- Sore throat
- Congestion or runny nose
- Nausea or vomiting
- Diarrhea

### **SCHOOL-TO-HOME COMMUNICATION**

In the event one of our schools is required to transition from one learning model to another, the school district will use the following communication outlets to inform families:

- Lancaster Community Schools website (www.lancastersd.k12.wi.us)
- Lancaster Community Schools Facebook page

- Area radio and television stations
- Lancaster Community Schools app

Should a student or staff member test positive for COVID-19, the school district will work with the Grant County Health Department to communicate information through the following formats:

• A letter will be sent home to families indicating an individual within one of our school buildings has tested positive for COVID-19

• If your child was in direct contact with the individual who tested positive, you would be contacted by the Grant County Health Department.

• A push notification will be sent via the Lancaster Community Schools app, providing a more immediate sharing of information

### **SURVEY FEEDBACK**

Lancaster Community Schools surveyed school district families and staff regarding returning to school for the 2020-2021 school year. A total of 314 families responded to the survey (56.3 percent response rate).

#### **Winskill Elementary School**

163 families (75.1 percent) indicated face-to-face instruction with enhanced safety precautions was an acceptable solution, while 40 families indicated blended instruction was an acceptable solution and 16 indicated virtual instruction was an acceptable solution.

41 staff members (74.5 percent) indicated face-to-face instruction with enhanced safety precautions was an acceptable solution, while 11 staff members indicated blended instruction was an acceptable solution and eight indicated virtual instruction was an acceptable solution.

#### **Middle/High School**

163 families (72.4 percent) indicated face-to-face instruction with enhanced safety precautions was an acceptable solution, while 64 families indicated blended instruction was an acceptable solution and 37 indicated virtual instruction was an acceptable solution.

32 staff members (59.3 percent) indicated face-to-face instruction with enhanced safety precautions was an acceptable solution, while 15 staff members indicated blended instruction was an acceptable solution and five indicated virtual instruction was an acceptable solution.
